**“STRENGTHEN YOUR BROTHERN” (Luke 22:32)**

For seven weeks we have been exploring the Sacrament of Anointing of the Sick in answer to a parishioner’s question: **“Who is a person to call if somebody needs the last rites before death?”** If you missed any of this series they are available 24/7 on our parish website [www.svecatholic.org](http://www.svecatholic.org). In this week’s final installment we examine just **who and under what circumstances someone is able to receive the Sacrament of Anointing of the Sick.**

Since the effects of the Sacrament of Anointing of the Sick include “the uniting of the sick person to the Passion of Christ for his own good and that of the whole Church [as well as] the strengthening, peace, and courage to endure in a Christian manner the sufferings of illness or old age” (*Catechism of the Catholic Church*, 1532), the **one to be anointed must already have been incorporated into the Death and Resurrection of Christ through the waters of Baptism.** The *Praenotanda* or Introduction to the book that guides the Priest through the ritual of the Anointing of the Sick **exhorts all the Christian faithful that “great care should be taken to see that those of the faithful whose health is seriously impaired by sickness or old age receive this sacrament”** (*Pastoral Care of the Sick: Rites of Anointing and Viaticum*, 8). In other words, **it is the responsibility of the entire community to be attentive to those experiencing serious health issues ensuring that they have access to the Sacrament of Anointing of the Sick in a timely manner.** In particular this means **the faithful must not unnecessarily delay asking the Priest to celebrate this sacrament.** In 25 years of priestly ministry all too often the seriously ill do not receive the Sacrament of Anointing of the Sick. To be extremely blunt, sometimes this happens because requesting the sacrament does not even cross the minds of the sick person or his family due to their lack of faith. Because of the way they approach life – with little or no appreciable faith – it simply does not occur to them that Christ wants to accompany them in illness and death. Other times a defective understanding of the Sacrament of Anointing of the Sick – seeing it only as so-called “last rites” for those whose death is imminent – leads the sick person or his family to request it way too late in the dying process. In such cases, the person dies before the Priest can get to him because the sacrament was not requested in a timely manner.

When a person’s health has become **seriously** impaired due to illness or old age, the time has already arrived to receive the Sacrament of the Anointing of the Sick. Among those who may be anointed, the *Pastoral Care of the Sick* ritual book indicates in particular: **those undergoing surgery “whenever a serious illness is the reason for the surgery”** (10); **the elderly who “have become notably weakened even though no serious illness is present”** (11); **sick children even if there is some doubt as to whether they have attained the use of reason** (see 12; also *Code of Canon Law Annotated*, 1004). The ritual book notes that **“a prudent or reasonably sure judgment, without scruple, is sufficient for deciding on the seriousness of an illness”** (8). The Sacrament of Anointing of the Sick is one that the faithful can receive more than once. The *Catechism of the Catholic Church* teaches us that “if a sick person who received the anointing **recovers his health**, he can in the case of another grave illness receive this sacrament again. If **during the same illness the person’s condition becomes more serious**, the sacrament may be repeated” (1515). The *Code of Canon Law* notes two final considerations regarding the Sacrament of the Anointing of the Sick. “This sacrament is to be administered to the sick who, when they were in possession of their faculties, **at least implicitly asked for it**” (1006). As with the other sacraments, in order for the sacrament to have its proper effect in the life of the recipient, the person must have the intention to receive that which Christ and His Church offer through the particular sacrament. For any baptized Catholic, then, it is *presumed* that they desire to receive this sacrament even if they did not explicitly request it or they are no longer able to communicate this desire. However, “the Anointing of the Sick is **not to be conferred upon those who obstinately persist in a manifestly grave sin**” (1007). Since this is a sacrament of healing and forgiveness, if the person shows no sign of repentance or openness to reconciliation with God and His Church, then it makes no sense to offer to him something he deliberately rejects.
