Following the recent Supreme Court *Obergefell v. Hodges* case, many people say that the decision is about homosexuality, equal rights, and justice versus bigotry, ignorance, intolerance, and hatred. In fact, at its core this decision of five lawyers is **about the very nature of marriage itself**. This week I invite you to continue to listen to voices that do not get a hearing in the soundbites that now pass for journalism. Dr. Jennifer Morse has taught at Yale University and George Mason University and is the author of *The Sexual Revolution and Its Victims*. She wrote one of the *amicus* briefs for the Supreme Court justices regarding the *Obergefell v. Hodges* case. Morse analyzed the decision in the June 29 online edition of *Crisis*. Like the voice we heard in this column last week – Ryan T. Anderson – her objection to the *Obergefell v. Hodges* decision is based on reason, not faith (although she is a devout Catholic woman). And like Anderson, her opposition does not come from bigotry, ignorance, intolerance, or hatred. Morse writes: “**The Court’s cavalier disrespect for the rights of children is its most striking feature. Redefining marriage redefines parenthood. Up until now, marriage has been the primary institutional structure that attaches mothers and fathers to each other, and to their children. With Obergefell, this historic social purpose of marriage has come to an end.** Nothing remains of marriage in Justice Kennedy’s telling but a **government registry of friendships**. Of course, no one truly needs a government registry of friendships. We will soon hear calls to abolish even this vestigial form of marriage.”

Focusing in on the injustice this ruling perpetrates on children Morse continues: “So **how will society attach children to adults, in the post-Obergefell world?** (1) **Parenthood will no longer be considered a natural reality to be recorded by the government, but a creation of the State for the benefit of adults;** (2) Some children will have a legally recognized **right to know both of their parents**. Other children will be blocked by the State from knowing both parents; (3) Some children will have **three or more people named on their birth certificates;** (4) **People related to the child neither through birth nor adoption will demand parental rights.** Family courts will adjudicate these disputes on a case-by-case basis, using subjective criteria; (5) **Parenthood by contract** among Intended Parents will become legally enforceable by the states; (6) **Third Party Reproduction** will continue unregulated and unabated. By the time the general public figures out that **this is a form of human trafficking, baby-selling, and a human rights abuse**, it will be so entrenched that it will be difficult to root out. We can extrapolate from 45 years of experience with divorce and unlimited remarriage to see that these “alternative family forms” will be harmful to children. As my colleague Jennifer Johnson memorably put it, **‘I had five parents and it sucked.’**”

Regarding the rights of children, Morse laments: “I was especially disturbed to see that even the dissenters do not give **children’s rights** the attention they deserve. Justice Thomas came close to the mark by saying that the government does not bestow dignity on anyone: the government recognizes the dignity that is inherent in each and every human being. Justice Alito comes close by saying that marriage does have a legitimate procreative purpose, while criticizing the majority for saying ‘the fundamental purpose of marriage is to promote the well-being of those who choose to marry.’ But even this is a far cry from a **robust analysis of the rights and needs of children.**”

Most Sacred Heart of Jesus, have mercy on us! Holy Family of Nazareth, intercede for us!
